## REC MARKETS NEW RETAIL DEVELOPMENT IN DARIEN, ILLINOIS

Darien Pointe Plaza presents two new retail strip centers currently under construction and making excellent progress at the corner of S. Cass Avenue and Plainfield Road. Designed by Shive-Hattery Architecture Engineering, the new plaza development is being constructed in accordance with plans drafted by the City of Darien.

The community views this project as a significant improvement to the corner providing a dynamic focal point for a 'town center' in Darien. Additional amenities here include two large street pylon monument signs shared with Chase Bank with one located at the Plainfield Road entrance and the other at the lighted 75th Street/Cass Avenue intersection.



Overall redevelopment of this site includes a new 30' tall triangular clock tower which sounds at the top of each hour, water features and a park area at the corner of Cass Avenue and Plainfield Road. The park area features includes a brick-paved courtyard, ornamental plants, park benches and natural stone accents.

- **SOUTH BUILDING:** 7533 S. Cass Avenue  
Approximately 7,400 square feet and a drive-through
